



Glen Reed stands out as a member of our class who has dedicated significant time in his professional career and personal life in the service of others. Glen practiced law for more than 40 years at King & Spalding's Atlanta office,



specializing in legal support for the health-care industry in the United States. Glen was one of the founders of the health-care practice at King & Spalding and was a national leader in the health-care bar. Under Glen's stewardship, the health-care practice at King & Spalding was consistently ranked number one in the country by the American Health Lawyers Association and won the Chambers USA Award for Excellence in Healthcare. Glen's legal accomplishments were recognized by his selection to Super Lawyers, The Best Lawyers in America, Legal Media Group's Guide to the Leading U.S. Healthcare Lawyers, Who's Who in American Law, Who's Who in America, and Who's Who in the World. Glen retired from King & Spalding at the end of 2020. Since then he has continued working on various civic and charitable projects.

Glen served as a founding board member and board chair of Med-Share International, which provides health-care equipment and medical supplies to underresourced health-care providers internationally. He also served as a member of the board of directors and executive committee of MAP International, an international health charity focused on improving the availability of essential medicines to needy communities in various parts of the world. Glen has served on the Dean's Council of

the Rollins School of Public Health at Emory University. Glen has also participated in several other civic and professional organizations, having served as a board chair of the Visiting Nurse Health System and of the Atlanta Alliance on Developmental Disabilities.

Glen is the chair and CEO of his family's private foundation, The Reed Foundation, which focuses on improving international and domestic access to health care resources, water, and food and also contributes to the arts, education, and animal rescue. Glen's family has also provided funding for programs on legal and public policy topics presented by The Buckley Institute and the William F. Buckley Jr. Program at Yale University. By the end of 2024, this included three annual discussions of U.S. Supreme Court decisions, a debate on Supreme Court term limits, and two programs on K-12 education. Glen was also among the sponsors of the Buckley Institute's Disinvitation Dinner at the Plaza Hotel in New York in 2023. Glen and his wife Edie were pleasantly surprised to be afforded a memorable opportunity to converse with the speaker, Dr. Jordan Peterson, over dinner before his talk.

I know I am joined by all our classmates in expressing to Glen our deepest admiration and gratitude for a lifetime that has included such profound national, international, and philanthropic service.

Mary Hutchings Reed is a classmate who, like some of our other classmates chronicled in our class notes, has lived two very different but equally accomplished careers. In September, Mary published her sixth novel, "Harmony's Peace and Joy" (Ampersand, 2024), a contemporary story featuring "White deer and wisdom. Broken bowls and healing. A family motto and sibling rivalry." Book-Life's review says it "offers great drama." Last year, Mary's historical novel "Free Spirits" (2023) was a top-eight finalist for the Pacific Northwest Writers Award for historical fiction. In 2016, "One for

the Ark" was the Bronze Medalist for the Foreword Reviews INDIES Prize, and her novels "Warming Up" (2013) and "Saluting the Sun" (2015) were also finalists for the INDIES prize. She has also won awards from BookLife, the Independent Press Awards, the International Book Awards, the Colorado Independent Press Association, the Illinois Library Association, the Erif Hoffer Awards, Hidden River Arts, and the William Wisdom/William Faulkner Competition. 
Classmates were also thrilled for Mary when her novel "Saluting the Sun" was produced as a new musical at the Edge Theater in Chicago in 2023. Mary Faucher '77 attended and was a major benefactor of the production. Her musical "Fairways," about golf, honesty, and love, was produced three times in the Chicago area to sold-out audiences, and Mary also attended that premiere in 2006.

Mary spent her first 40 years after Yale Law successfully practicing law, first with Sidley Austin and then with Winston & Strawn, two preeminent Chicago law firms. She served as a partner at both firms, with a concentration in representing advertising agencies and in trademark, copyright, entertainment and sports law. Her clients ranged from the American Library Association to boxing promoter Don King. Mary was frequently listed on Super Lawyers and Best Lawyers lists and was named Chicago's Advertising Lawyer of the Year by Best Lawyers in 2012 and 2014. Also involved in community service, she has served on the boards of various nonprofit organizations, including the American Civil Liberties Union of Illinois, the YWCA of Metropolitan Chicago, the Chicago Bar Foundation, and the Legal Assistance Foundation of Metropolitan Chicago, which awarded Mary its highest honor, its "Champion for Justice Award." She also serves on the board of Lawyers for the Creative Arts, which represents emerging

not-for-profit arts organizations and artists, and received its highest honor in 2004 and wrote its history in 2012, "LCA: The First 40 Years."

Mary retired from the practice of law in 2015 to pursue writing, but she also finds time for golf, sailing, tennis, and competitive bridge. Our intrepid classmate describes a life-changing sailing trip in 1992, when she and her husband, an internist, sailed from Norfolk, VA, to St. Thomas, USVI, a journey of 1,500 miles. "It was amazing, especially encountering three terrible storms, hundreds of miles off shore, all alone. It was a profoundly spiritual experience - made me realize there were things I wanted to do in addition to practicing law."

Jonathan Rosenblum '77 is another classmate who is a distinguished writer of a dozen books and has been called the most widely read and influential Chareidi writer in English, Jonathan, who lives in Jerusalem, has written a new book, "Ordinary Greatness - 100 Songs of Praise," a collection of essays on both extraordinary and ordinary people. These 100 portraits describe those who had a great impact on Jonathan's life most of them unheralded outside their family and community, some world-famous, most of whom he knew personally, and some of whom he discovered only through
